Course Description:

A study of basic macroeconomic concepts, principles, and terminology. Attention is given to supply and demand, national income, unemployment, money and banking, international trade and finance.

Course Competencies:

The learning outcomes and competencies detailed in this syllabus meet or exceed the learning outcomes and competencies specified by the Kansas Core Outcomes Groups for this course as approved by the Kansas Board of Regents. Upon completion of the above listed course, students will be able to do the following:

1. Demonstrate the economic way of thinking including scarcity, opportunity cost, production possibility, and marginal analysis.
2. Utilize the supply and demand model to analyze market outcomes.
3. Apply the key macroeconomic indicators to interpret the performance of the aggregate economy including output, price level, and employment.
4. Utilize economic models to explain changes in short-run fluctuations and long-term growth.
5. Evaluate the impacts of fiscal policy on the macroeconomy.
6. Define money and banking, then evaluate the impacts **on the** monetary policy on the macroeconomy.
