Course Description:

This class is designed to give the second semester student supervised practice with computerized testing. Students will apply previously learned skills and concepts in preparation for the CompTIA Network+ Examination. Practice test banks will be used to simulate the exams. Students will take practice tests, review answers, research any incorrect answers and research and obtain correct answers.

Course Competencies:

The learning outcomes and competencies detailed in this syllabus meet or exceed the learning outcomes and competencies specified by the Kansas Core Outcomes Groups for this course as approved by the Kansas Board of Regents.

Upon completion of the course, the student should be able to:

1. Consistently pass practice Network+ Exam with a minimum of 90% accuracy
2. Research incorrect answers to questions on the practice exams and obtain correct answers
3. Take the CompTIA Network+ Exam
